MISSION STATEMENT

Jassac Charitable Foundation, Inc. is a charitable corporation committed to providing programs that enhance the cultural, educational, and economical needs of the community; enrich the lives of youth through mentoring and tutoring programs; and promote community awareness of health concerns to individuals and families in the Southland area of Cook County, Illinois.

HISTORY

Jassac Charitable Foundation, Inc. (referred to as JCFI) was established in 2003 as an Illinois not-for-profit corporation. The Foundation is a 501(c)(3) organization and all donations and contributions are tax deductible to the extent of the Internal Revenue Service tax regulations. The primary purpose of the Foundation is to support programs, in the Southland area of Chicago, Illinois that enhance the cultural, educational and economical needs, enrich the lives of youth through mentoring and tutoring programs and promote community awareness on mental and physical health concerns.

The Foundation evolved from a site committee that was established in 2002 with twenty members. The committee's responsibility was to vigorously pursue locations and selections of appropriate property to recommend to the Joliet Area/South Suburban Alumnae Chapter of Delta Sigma Theta Sorority, Inc. for purchase, to house community programs and projects. With this goal in mind, the committee proceeded to form the not-for-profit organization, which is known as, Jassac Charitable Foundation, Inc., effective October 18, 2005. The original name was Jassac, Inc., NFP.

Jassac Charitable Foundation, Inc. believes the strength of any community is based on the education and well-being of its people.

GOVERNOR'S STATE

In the Fall 2013, the Jassac Charitable Foundation, Inc. established a scholarship in honor of Ms. Lorine S. Samuels, long - time consultant of the Foundation, a proud member of Delta Sigma Theta Sorority, Inc. and Past National Treasurer from 1981 to 1985. Lorine S. Samuels is President and Founder of Strategic Business Services, Inc. (SBS), a financial and management consulting firm - established in 1985 - located in Flossmoor, IL.

Prior to starting SBS, Ms. Samuels had over 20 years of experience working in corporate and nonprofit entities. In addition, she has taught business classes at Joliet

Community College and Prairie State Community College. She has conducted workshops and written articles on business and financial planning. Ms. Samuels completed Executive Training Programs at The University of Miami, FL, School of Business Administration and the University of Texas at El Paso, TX.

Ms. Samuels is a graduate of Roosevelt University, Chicago, Illinois, and she has engaged in graduate study at Lewis University and Governors State University (GSU). She was appointed, by the Illinois Governor, to the Board of Trustees in 2000. Her appointment made the first African American female on the board of trustees, and she served as its first African American Chairperson from 2007 through 2011. She transitioned off the GSU Board of Trustees in February, 2013.

COMMUNITY PROGRAMS AND PARTNERSHIPS



The Jassac Charitable Foundation, Inc. supported many programs and projects, in this fiscal year, through joint – venture agreements covering initiatives such as Health, Education, International Awareness and Community Involvement. Our community outreach projects reached over 22 communities and served thousands of citizens.

BREAKFAST WITH SANTA

In preparation for this event, hundreds of letters were mailed to schools, city officials and businesses within the Joliet, IL community. Flyers were distributed throughout the Joliet, IL community and local media were sent press releases. A total of 537 children received free breakfast, toys and hat and glove sets. Children had an opportunity to win one of 100 shiny new bikes and over 200 coats were given to those

in need. Demographics for families who attended this event were comprised of 16 communities consisting of Joliet, Lockport, Bloomington, Lansing, Robbins, Calumet City, South Holland, Plainfield, Homewood, Harvey, University Park, Shorewood, Hazel Crest, Matteson, Chicago Heights and Chicago.

The Mayor of Joliet, Illinois, Bob O'Dekirk, made an appearance and thanked the members of JASSAC and the Jassac Charitable Foundation for sponsoring this event which made a great impact in the community. Members from the Joliet Police Department assisted with putting bikes together and the Joliet Fire Department transported Santa Claus to the event on a fire engine.



On-site voter registration was made available by the JASSAC Social Action Committee and the Joliet Park District provided information on winter programs. Information provided was available in both English and Spanish. Several students from Rosa L. Parks Middle School earned community service hours by making snowflake decorations for this event.

COMMUNITY EXPO

The community expo was a collaboration between Joliet Area South Suburban Alumnae Chapter of Delta Sigma Theta Sorority, Inc. and Jassac Charitable Foundation as well as community social service agencies and vendors. Members of Delta Sigma Theta Sorority, Inc., Joliet Area/South Suburban Alumnae Chapter, Mayor Vivian Covington, Village of University Park, First Baptist Church of University



Park and The Insurance Exchange hosted an EXPUNGEMENT WORKSHOP on October 17, 2015 10 a.m. to 2 p.m. at the Town Center Building, 90 University Parkway, University Park, IL. Illinois State Representative Anthony Deluca was also present along with the Will County Clerk, Pamela McGuire, Will County State's Attorney, James W. Glasgow, and residents of Will County and South Cook County of Illinois. Residents learned what an expungement is; how a record can be expunged; received job readiness training information/potential job referrals and resources for returning citizens. 
The 2015 Community Expo was also held Saturday October 17, 2015 at Thornton Township High School, Field House (1500 S. Broadway Ave – Harvey, IL) from 10am -2pm. There was FREE ADMISSION and services such as blood pressure screenings, diabetes screenings and Voters Registration. Scholarship information was provided as well as several authors represented the arts in the authors pavilion. We even had something for the children in the Kids Fest room where various activities were held for our youth. The International Awareness and Involvement committee also presented an authentic African drummer as entertainment for the day. Dignitaries were also present, including candidate for Cook County State's Attorney, a representative for Senator Napoleon Harris, and other elected officials.

SOUTH SUBURBAN P.A.D.S



The South Suburban P.A.D.S. (Public Action to Deliver Shelter -www.sspads.org) is an ecumenical program providing shelter and supportive service to homeless persons. P.A.D.S. provide services for men and women and children through four interrelated programs. It provides overnight shelter, free primary care medical clinic, a year round daytime supportive service centers, and a homeless preventive program.

Over the past eight years, Jassac Charitable Foundation, Inc (JCFI). has been an integral part of the South Suburban P.A.D.S. Program. The Foundation makes a financial contribution and provides food and supplies. The members of JCFI volunteer in two communities: New Faith Baptist Church located in Matteson, Illinois every 4th Thursday night and Friday mornings and St. Irenaeus Catholic Church located in Park Forest, Illinois every 2nd Thursday and Friday mornings.






In this fiscal year, at St. Irenaeus we attended to approximately 283 guests in approximately 477 hours donating thousands of dollars.

YOUTH EMPOWERMENT

The Youth Empowerment Conference is a day conference that is dedicated to empowering our youth in areas such as social media, police interactions, college prep to name a few. It was free admission but does require students to pre-register. This year's conference had over 120 youth and parents in attendance. There were 6 workshops provided that received a 90% or above rating on evaluations. Lastly it included 2 chats with legislators, Representative Will Davis, Thaddeus Jones and Elgie Simms and the Far South Suburban NAACP.



GLOBAL AWARENESS & INVOLVMENT



The Global Awareness and Involvement water well project will provide clean and safe water to communities, villages and schools in Africa and Hati. This year's donation for the water well supported the East African Village Outreach. The water well will be built in Ethiopia and will provide clean water to two villages and to the nearby schools. Children are often victims of water related illness which leads to decrease in cognition ability and attention deficit and absenteeism from school. Men, woman and children will benefit from this water well ranging in age from very young to very old.

BE U TOUR

The Be U Empowerment Tour is a positive resource that constructively influences young girls early in their social development to inspire self-confidence, self-control and esteem.

This year's tour included our VIP Red Carpet Reception, Pep Rally and Runway Walk Finale. Each part of the tour is designed for each participant to not only be empowered but to engage and be heard.

Over 200 participants were in attendance and the special guest keynote speaker was Drew Sidora.


The Jassac Charitable Foundation, Inc. was the fiscal sponsor for several events this fiscal year through joint – venture agreements.










CRIMSON & CREAM PAGAENT
